A newly launched website presents information on "Interreligious Dialogue in Austria". The website was designed and created by Univ.-Prof. Dr. Wolfram Reiss and Mag. Robert Wurzrainer in cooperation with students from different disciplines over the past two years. The main aim of the website is to provide an overview of the approximately 50 different initiatives for inter-religious dialogue in Austria, as a condensed general overview has been lacking up to now. In addition to initiatives of institutions at international, national, provincial and municipal level, cooperations that promote, mediate and analyse interreligious dialogue are presented. Forms of practical interreligious cooperation in private, public and state organisations are also presented, as are interreligious dialogue initiatives by NGOs and various religious communities.

Sondage(s) / Survey(s)

- [New numbers on religious affiliation](#) have been released by the Statistics Austria (Federal Agency): Information on religious affiliation for the total population is available from 1951 to 2001 in the form of self-declaration from the censuses. Since the censuses changed to a register-based survey, data on this characteristic is no longer collected within the framework of the census. In 2021, Statistics Austria conducted a voluntary survey on "Religious affiliation of the population in private households" on behalf of the Federal Chancellery, which, after estimating the religious affiliation of the institutional population, supplements the time series since 1951.

• SEVENTH-DAY ADVENTIST AT THE SUPREME COURT

In 2022, a discrimination case regarding a Seventh-Day Adventist gym teacher, who was fired in 2017 for refusing to work on a Saturday, reached its final ruling in the Danish Supreme Court. On a Saturday, the school where he was the only gym teacher employed had scheduled an Open House day to advertise the next year’s classes and programs to potential students and their parents. The Seventh-Day Adventist insisted on his right not to work on a Saturday, and after management had argued it was required, he did not show up and was subsequently fired. He brought the case before the Board of Equal Treatment in 2018, who ruled that the requirement to work on a Saturday was indirect discrimination, because it was a seemingly neutral requirement that nevertheless placed the Seventh-Day Adventist in an disadvantaged position. Although the requirement to work was reasonable and justified, the Board of Equal Treatment found that the school had not demonstrated that it was necessary and that they had not explored other reasonable and proportionate options.

In 2021, the Western High Court overturned the ruling by the Board of Equal Treatment. It found that the firing was justified and that the management had in fact explored other options, but dismissed these in favour of insisting the gym teacher’s presence, and that they had a certain margin of appreciation in maintaining that the teaching on the Saturday should be held to the expected academic level. The School had convincingly argued that it had occurred undue burden in finding last-minute replacements, and that the situation was unlikely to be a singular occurrence, and therefore were justified in proceeding to fire the gym teacher. The Board of Equal Treatment brought the case before the Supreme Court and in a particularly clear ruling, the Supreme Court upheld the Western High Court ruling. The Supreme Court recognised that the schools insistence on working on a Saturday was in fact discriminating the Seventh-Day Adventist gym teacher regarding his faith or belief, but that it was justified, proportionate and – on the basis of management’s margin of appreciation also necessary for the gym teacher to appear, nevertheless.

• CRITICISM OF THE MINISTRY OF ECCLESIASTICAL AFFAIRS

During 2022, the Danish Ministry of Ecclesiastical Affairs received significant and serious criticism for its lengthy and unsatisfactory case processing and administration. The criticism was two-fold. Religious communities, university professors and media criticized the Ministry for very lengthy case processing in cases, where religious communities had applied for recognition under the *2018 Act on Religious Communities outside the Church of Denmark*. The core of the criticism was that some of the case had been under way for several years, but the

Ministry argued that the prolonged time was caused by COVID-19 and understaffing. From the State Auditors, the Ministry was criticized for their unsatisfactory processing of the documents and financial accounts, which recognized religious communities are required to submit every year. The Ministry had assumed that random samples would be sufficient to check the documents and financial accounts, but there were errors and problems in 74 per cent of the checks. The State Auditors held the Ministry accountable, despite disagreement about the degree of control expected from the Ministry. During the summer 2022, the Ministry devised a four point strategy to improve, and announced upcoming revisions to the Act on Religious Communities.

- DECORUM

During summer and fall of 2021, a serious case of abuse of confessional decorum has been ongoing in the Church of Denmark. Several women reported unwanted sexual attention from a parish priest in Copenhagen. He has taken a leave of absence after complaints were filed to the bishop with several testimonies of both abusive behavior and breach of confidentiality. More than a year since the first reports, the case was closed after an initial, but undisclosed legal examination, which caused the parish priest to quit the job.

- The Council of State (Decision 1478/2022) annulled a joint ministerial decision, regulating the exemption of students from religion education, because prior to its issuance, the provision of the opinion of the Personal Data Protection Authority was not taken into consideration by the Ministry of Education. According to the judgment of the Court, the provision of the opinion of the Personal Data Protection Authority was required, as an essential act, which, however, as it appears from the data in the file, does not exist. In addition, according to the court the end of the 2022-2023 is a reasonable time to establish an equal course of related content for students who are exempted from the compulsory RE in accordance with the interpretation of the constitutional and extra-legislative provisions of the ECHR.
- The Hellenic Data Protection Authority examined a draft of the Ministry of Education regarding the amendment of article 25 “Exemption of students from active participation in courses” of no. 79942/GD4/21-5-2019 of ministerial decision “Registrations, transfers, attendance and matters of organization of school life in secondary schools”. Regarding the exemption of students from Religious Education, the Authority expressed the opinion that the Ministerial decision about the right to be exempted from RE, is not in accordance with the current Greek Constitution and the ECHR since it implicitly asks parents/ students to reveal their religious beliefs.

Décisions Juridiques / Legal Decisions

- *Brown v. Planet Fitness (Dundas)*, 2022 HRTO 1178—The Applicant argued a public gym facility discriminated against his creed by instituting a mandatory vaccine policy. The Human Rights Tribunal of Ontario concluded that the Applicant’s creed did not meet the requirements of a creed under the province’s *Human Rights Code*. The Tribunal noted in part that the Applicant’s creed is missing an ‘overarching systemic component.’
- *Corion v Plummer*, 2022 CanLII 84382 (ON SCSM)—The Plaintiff is a member of the Seventh-Day Adventist Church. He claimed that the Defendant told members of the Church that he is gay, both verbally and by text message, and he argued that this diminished him in the eyes of his wife and church members. The Court dismissed the claim and held that being called gay is not defamatory.
- *Demir v. Canada (Citizenship and Immigration)*, 2022 FC 1321—The Applicant sought judicial review of a decision by the Refugee Appeal Division of the Immigration and Refugee Board, which affirmed the Board’s earlier decision to deny the Applicant protection as a refugee. The Applicant claimed he would be persecuted by authorities and Sunni extremists if he returned to Turkey because he is Alevi. The Court denied his application for judicial review.
- *Kandaharian (Litigation Guardian of) v. York Catholic District School Board*, 2022 ONSC 4969—A high school student in the province of Ontario was rescinded of her candidacy for student trustee because she was not baptized Roman Catholic, as required by Policy 107 of the York Catholic District School Board. The Court squashed this policy and concluded that restricting student representation based on religion is outside the authority of the School Board.
- *Nokusis v Saskatchewan Government and General Employee’ Union*, 2022 CanLII 90619 (SK LRB)—The Labour Relations Board of the province of Saskatchewan granted the application of a Jehovah’s Witness to exclude herself from her employer’s bargaining unit and union dues. The Applicant explained that she views unions as ‘political entities’ and that participating in one goes against her religion’s requirement of political neutrality.
