- **Corte di Cassazione, 11.03.2022, n. 7980 – ICI - MUNICIPAL PROPERTY TAX**
On the subject of ICI, Italian municipal property tax, the exemption ex art. 7, comma primo, lett. i), del d.lgs. n. 504 del 1992, is subordinated to the coexistence of an **objective requirement**, represented by the exclusive performance in the building of **assistance activities or other activities equivalent** by the legislator for the purposes of the exemption, and a **subjective requirement**, consisting of the performance of these activities by a public or private body that does not have as its sole or main object the exercise of commercial activities (art. 87, 1 comma, lett. c), d.P.R. 22 dicembre 1986, n. 917). **The existence of the objective requirement must be concretely ascertained**, verifying that the activity for which the property is intended, even though it is one of the exempt ones, is not carried out in the manner of a commercial activity (Cass. n. 4502/2012, n. 14226/2015. Even welfare and receptive activities can determine, like religious or cult activity, the exemption ICI, ex art. 7, I, i), d.lgs. n. 504/1992. **The exemption in question, provided for properties intended exclusively for the performance of religious or cult activities** ex art. 16, lett. a), L. 20.05.1985, n. 222, **belongs to an ecclesiastical body in relation to a building intended for the dwelling of members of its own religious community**, in a manner comparable to the dwelling of a real estate unit by the owner and his family members, resulting in the carrying out of a non-commercial activity, but aimed at the "training of the clergy and religious", expressly included in the list ex art. 16, a) cit. and also having the characteristics of "hospitality" activity, also included in the exemption ex art. 7, comma 1, lett. i) cit.
- **Corte di Cassazione, 15.02. 2022, n. 4980 – TEACHER OF RELIGION**
The activity of assistance to the individual study of the students, substituting the teaching of religion, expressly the object of the teacher's assignment, determines the obligation to be present at the ballots, since this activity cannot be reduced to a role of simple surveillance, but materializing in a teaching support activity, relevant for the **purpose of attributing and calculating school credit**.
- **Corte di Cassazione, 27.01.2022 n. 3808 - SHOAH - DENIAL - CRIMINAL AGGRAVATING CIRCUMSTANCE**
The criminal aggravating circumstance of denial to a fact of propaganda of ideas based on superiority or racial or ethnic hatred and the denial of the Shoah. As is known, the aggravating circumstance in question has been introduced in 2016 (with L. 16.06. 2016, n. 115), amended the following year (with L. 20.11.2017, n. 167), when the incriminating provisions were still contained in art. 3 L. 13.10. 1975, n. 654 (bearing "*Ratification and execution of the international convention on the elimination of all forms of racial discrimination, opened for signature in New York on 7 March 1966*"), provision that was subsequently transferred to art. 604-bis of the Criminal Code.
- **Corte di Cassazione, 20.01.2022, n. 2242 - "DISTURBANCE" OF THE RELIGIOUS FUNCTION**
For the purposes of configuring the crime referred to in art. 405, cod. pen., the conduct of "disturbance" of the religious function can also be integrated by its exploitation for purposes contrary to the religious sentiment of those who take part in it and which the function itself intends to evoke and honor. (*Case relating to two stops in front of the home of the close relatives*

of the head of "Cosa Nostra", carried out, without justification, during the course of a religious procession, which took place in a public place and with the assistance of a minister of worship).

- **Corte di Cassazione, pen., 09.02.2022, n. 4534 - DISCRIMINATION AND VIOLENCE FOR RELIGIOUS REASONS**

Integrates the crime referred to in art. 604-bis, II co°, c.p., joining a virtual community characterized by a neo-Nazi ideological vocation, having among its aims the propaganda and incitement to discrimination and violence for racial, ethnic or religious reasons and sharing, on the bulletin boards of its "social" platforms, of messages of clear denial content, anti-Semitic and discriminatory for reasons of race, through the insertion of "like" and the relaunch of "posts" and related comments, due to the high danger of spreading such ideological contents among a number indeterminate number of people deriving from the "social network" function algorithm, which increases the number of interactions between users.

- **Corte di Cassazione, 11.01.2022, n. 604 - JEHOVAH'S WITNESSES - RIGHT TO SELF-DETERMINATION IN HEALTH MATTERS**

The interest in acting against the provision which, despite the dissent of the parents and the minor, authorized the transfusion treatment due to the non-existence, that is the same abstract inconfigurability, of the infringement of the subjective rights proposed in the case, as an expression of the right to self-determination in health matters, in consideration of the fact that - at the time of the decision - the authorized transfusion treatment had been exceeded as it was made unnecessary during the diagnostic examination.

- **Tribunale Teramo, ord. 14.01.2022 - RECTIFICATION OF THE SEX - QUESTIONS OF CONSTITUTIONAL LEGITIMACY**

Multiple questions of constitutional legitimacy have been raised with reference to central provisions regarding the **impossibility of converting the civil union into marriage as a result of the rectification of the sex of one of the two members of the couple.**

- **2022 - DISCIPLINARY MEASURE OF A RELIGIOUS NATURE - EXPULSION FROM THE RELIGIOUS COMMUNITY**

With reference to the trade union on the expulsion measures adopted by religious confessions other than the Catholic one, the thesis of the United Sections of the Supreme Court of Cassation is confirmed, which have clarified that a power recognized to religious confessions and implying **a total prohibition of interference is highlighted by the state.**

- **Consiglio di Stato, 16.03.2022, n. 1842 - RELIGION TEACHERS.**

The Council of State recognizes the right to the Teachers' Charter for annual religion teachers.

- **Corte Costituzionale, 15.02.2022, n. 50 – MINIMUM PROTECTION OF HUMAN LIFE**

The Constitutional Court has declared inadmissible the request for a popular referendum for the partial repeal of art. 579 c.p., which would have had the effect of decriminalizing, with the exception of the cases provided for in paragraph III of the same article, the murder of the consenting party. The question was declared inadmissible because, following the repeal, *"the constitutionally necessary minimum protection of human life, in general, and with particular reference to weak and vulnerable people"*

- **Border crossing between Poland and Ukraine**

Since February 24, the first day of Russia's aggression, 3.13 million refugees (mainly women and children) from Ukraine have crossed the Polish-Ukrainian border. According to the UN, a total of over 5.264 million people have left Ukraine since February 24.

The office of the UN High Commissioner for Refugees forecasts that up to 6.5 million, and maybe even 7 million people from Ukraine, mainly women and children, will soon be living in the territory of the European Union. After registering in Poland, refugees from Ukraine receive social benefits at the same level as Poles. The refugees from Ukraine are able to work legally and have social and health insurance. Children can attend Polish public schools.

Décisions Juridiques / Legal Decisions

- *FLK Institute of Taoism v. MPAC*, 2022 ONSC 57—The appellant of this case, Fung Loy Kok Institute of Taoism (FLK), challenged the decision of an application judge to deny certain FLK properties municipal tax exemption. This included a site where FLK conducts Taoist Tai Chi classes. FLK argued in part that this site constitutes a place of worship, which is exempt from taxation, as opposed to a space for religious activities as determined by the judge. The court dismissed FLK’s appeal.
- *Ontario v. Trinity Bible Chapel*, 2022 ONSC 1344—Two churches located in the province of Ontario asserted that judicial orders obtained by the province in response to the pandemic infringed upon their constitutional right to religious freedom. The court determined that these restrictions did amount to a constitutional infringement, for they placed limits on their religious services and gatherings, but these limits were justified and reasonable in accordance with section 1 of the *Canadian Charter of Rights and Freedoms*. The court dismissed the motion to set aside the judicial orders.
- *Redmond v. British Columbia (Forests, Lands, Natural Resource Operations and Rural Development)*, 2022 BCCA 72—The appellant of this case applied for a licence to build a micro hydroelectric project in a creek located in Cheam First Nation territory. His application was denied because the project would have interfered with the Cheam First Nations’s right to practice spiritual bathing in the creek. The appellant argued that this outcome indicated preference for the Cheam’s spiritual beliefs over his atheism, which amounted to a breach of his constitutional right to religious freedom. The court dismissed the appeal and stated that the denial of the licence was unrelated to the appellant’s atheism.
- *Rinchen v. Canada (Citizenship and Immigration)*, 2022 FC 437—The applicant, a Buddhist monk of Tibetan ethnicity, sought judicial review of a Pre-Removal Risk Assessment (PRRA) decision that concluded he was unlikely to face harm or persecution in India or China. The applicant stated he fled from India to Canada because he feared being deported by Indian authorities to China, where he was expelled from a monastery for refusing to sign a declaration

vilifying the Dalai Lama. The court remitted his refugee claim for reconsideration by a different PRRA officer.

Autre / Others

- In February 2022, the New Democratic Party (NDP) tabled legislation in Ontario to combat Islamophobia and other forms of hate in the province. Among other measures, it called for a provincial review of hate crimes and hate-motivated incidents, and the establishment of a 50-meter safe zone around religious institutions that would prohibit acts of intimidation. The bill, for which the Ontario NDP partnered with the National Council of Canadian Muslims, failed to pass.
- Métis, First Nation, and Inuit delegates travelled to the Vatican in March 2022 to meet with Pope Francis and share their experiences of the legacy of Canada's residential school system. During this visit Pope Francis offered a public apology for abuses caused by some members of the Roman Catholic Church in residential schools. The apology received mixed reactions.
