Over the past three decades, issues related to religious freedom have become increasingly important across a global spectrum, prompting a growing interdisciplinary area of study. The discourses on religion and human rights, citizenship, and religion and state relations have become intertwined due to the shared centrality of the struggle over religious freedom. Scholars in political science, international relations, judicial studies and sociology have all contributed theoretical discussions, case studies and extensive empirical analysis. Recent developments involving social and religious dynamics related to migration, societal restrictions placed on religious freedoms, interaction between religious social movements and religious freedoms, and increasing visibility of religion in global politics are several examples where diverse theoretical approaches and analytical tools of social sciences can complement and challenge each other. While modern societies advance human rights promises by various legal and social mechanisms, they nevertheless face basic challenges of how these promises are to be defended, especially when ethnic, religious or class differences are factored into the picture. The promise of religious freedom has become a burgeoning social issue, which asks for both the social scientific answers and, in particular, for understandings of how different scientific outlooks see and interpret the current situation. In order to better address the issues, we invite participants to contribute theoretical perspectives, social science concepts and empirical analyses that highlight the development of religious freedom as an area of study in the social sciences. Actualité(s) juridique(s) / Legal news

- The National Police informed in July 2019 the public that 23 fines have been issued within the first year since a ban on public covering, the so-called burqa ban, went into force [1 August 2018](#). In September 2019, a case was tried in court to test the size of the fine. The Ministry of Justice had suggested a fine of DKK 1000 kroner for first time offenders, DKK 2000 for second time, DKK 5,000 for third time and then DKK 10,000 for later offences. The Court in Aalborg however adjudged a fine of DKK 2000 for [six offences](#). Since the law came into force on August 1, 2018 and even June this year, the police have raised a total of 39 charges. In 22 of the charges, the face had been covered with a [niqab or burka](#).
- According to a news report from the Ministry of Ecclesiastical Affairs of October 30 2019, six religious communities risk losing their position as recognized as they have failed to submit account reports to the ministry. The requirement to report and publish the annual accounts in the follows from the new Religious Community Law, which came into force on January 1, 2018. In 2019, therefore, it is the first time that reputed faiths and congregations are required to [report the annual accounts](#).

- Quebec’s Bill 21 has passed, “An Act respecting the laicity of the State/Loi sur la laïcité de l’État”. This bill forbids public sector employees like teachers, police officers, and judges in Quebec from wearing any visible religious symbols while performing their duties.
- Christian Medical and Dental Society of Canada v. College of Physicians and Surgeons of Ontario, 2019 ONCA 393. This ruling requires physicians in Ontario to provide an ‘effective referral’ for procedures that they have a moral objection to – notably MAID (medical aid in dying) and abortion.
- Wood v. Vancouver Coastal Health Authority and another (No. 2), 2019 BCHRT 113 (CanLII). Ongoing case of an atheist nurse with a substance abuse disorder whose physician required participation in a twelve step program to have his license reinstated. He refused, on grounds that twelve step programs require assertion of belief in a higher power.
